#### **PURPOSE:**

The purpose of this action is to seek adoption of an amendment to Section C under COMAR 13A.08.01.01 Attendance to provide for transfers to public kindergarten of age-eligible kindergarten students attending nonpublic kindergarten programs. This proposal is included as Attachment A. This amendment has no economic impact.

#### BACKGROUND:

In May 2005, the State Board of Education adopted COMAR 13A.08.01.01C, which permits a child who attends a nonpublic kindergarten program in this State for part of the year to transfer to a public kindergarten. The proposed amendment to Regulation .01C clarifies that a student transferring from a nonpublic kindergarten program must meet the minimum age requirement for admission to a public school kindergarten program, as set forth at COMAR 13A.08.01.02B(2).

#### **SUMMARY:**

The Department requests permission to amend existing COMAR 13A.08.01.01C. This amendment is intended to clarify language regarding the transfers of children from nonpublic kindergarten to public kindergarten in this State. No public comments were received.
